



"YET THIS DOES NOT INCLUDE THE HARMFUL EFFECTS OF LOCAL POLLUTANTS FROM OIL AND GAS EXTRACTION," SAYS THE DESCRIPTION, "WHICH CAUSE SERIOUS HEALTH PROBLEMS, LIKE LOWER BIRTH WEIGHTS, ELEVATED RISK OF LEUKEMIA, AND HIGHER ASTHMA RATES."
