4 **SEC. ____01. BORDER INFRASTRUCTURE AND WALL SYS-**
5 **TEM.**

6 In addition to amounts otherwise available, there is
7 appropriated to the Commissioner of U.S. Customs and
8 Border Protection for fiscal year 2025, out of any money
9 in the Treasury not otherwise appropriated, to remain
10 available until September 30, 2029, \$46,550,000,000 for
11 necessary expenses relating to the following elements of
12 the border infrastructure and wall system:

13 (1) Construction, installation, or improvement
14 of primary, waterborne, and secondary barriers.

15 (2) Access roads.

16 (3) Barrier system attributes, including cam-
17 eras, lights, sensors, and other detection technology.

18 (4) Any work necessary to prepare the ground
19 at or near the border to allow U.S. Customs and
20 Border Protection to conduct its operations, includ-
21 ing the construction and maintenance of the barrier
22 system.

1 **SEC. ____02. U.S. CUSTOMS AND BORDER PROTECTION PER-**
2 **SONNEL, FLEET VEHICLES, AND FACILITIES.**

3 (a) IN GENERAL.—In addition to amounts otherwise
4 available, there is appropriated to the Commissioner of
5 U.S. Customs and Border Protection for fiscal year 2025,
6 out of any money in the Treasury not otherwise appro-
7 priated, the following:

8 (1) PERSONNEL.—\$4,100,000,000, to remain
9 available until September 30, 2029, to hire and train
10 additional Border Patrol agents, Office of Field Op-
11 erations officers, Air and Marine agents, rehired an-
12 nuitants, and U.S. Customs and Border Protection
13 field support personnel.

14 (2) RETENTION, HIRING, AND PERFORMANCE
15 BONUSES.—\$2,052,630,000, to remain available
16 until September 30, 2029, to provide signing bo-
17 nuses, performance bonuses, or annual retention bo-
18 nuses to eligible Border Patrol agents, Office of
19 Field Operations officers, and Air and Marine
20 agents.

21 (3) VEHICLES.—\$855,000,000, to remain avail-
22 able until September 30, 2029, for the repair of ex-
23 isting marked patrol units and the lease or acquisi-
24 tion of additional marked patrol units.

25 (4) FACILITIES.—\$5,000,000,000 for necessary
26 expenses relating to lease, acquisition, construction,

1 or improvement of facilities and checkpoints owned,
2 leased, or operated by U.S. Customs and Border
3 Protection.

4 (b) RESTRICTION.—None of the funds made available
5 by subsection (a) may be used to recruit, hire, or train
6 personnel for the duties of processing coordinators after
7 October 31, 2028.

8 **SEC. ____03. DETENTION CAPACITY.**

9 (a) IN GENERAL.—In addition to any amounts other-
10 wise appropriated, there is appropriated to U.S. Immigra-
11 tion and Customs Enforcement for fiscal year 2025, out
12 of any money in the Treasury not otherwise appropriated,
13 \$45,000,000,000, for single adult alien detention capacity
14 and family residential center capacity.

15 (b) DURATION AND STANDARDS.—Aliens may be de-
16 tained at family residential centers, as described in sub-
17 section (a), pending a decision on whether the aliens are
18 to be removed from the United States and, if such aliens
19 are ordered removed from the United States, until such
20 aliens are removed. The detention standards for the single
21 adult detention capacity described in subsection (a) shall
22 be set in the discretion of the Secretary of Homeland Se-
23 curity.

24 (c) DEFINITION OF FAMILY RESIDENTIAL CEN-
25 TER.—In this section, the term “family residential center”

1 means a facility used by the Department of Homeland Se-
2 curity to detain family units of aliens (including alien chil-
3 dren who are not unaccompanied alien children (as defined
4 in section 462(g) of the Homeland Security Act of 2002
5 (6 U.S.C. 279(g)))) who are encountered or apprehended
6 by the Department of Homeland Security, regardless
7 whether the facility is licensed by the State or a political
8 subdivision of the State in which the facility is located.

9 **SEC. ____04. BORDER SECURITY, TECHNOLOGY, AND**
10 **SCREENING.**

11 (a) IN GENERAL.—In addition to amounts otherwise
12 available, there is appropriated to the Commissioner of
13 U.S. Customs and Border Protection for fiscal year 2025,
14 out of any money in the Treasury not otherwise appro-
15 priated, to remain available until September 30, 2029,
16 \$6,168,000,000 for the following:

17 (1) Procurement and integration of new non-
18 intrusive inspection equipment and associated civil
19 works, including artificial intelligence, machine
20 learning, and other innovative technologies, as well
21 as other mission support, to combat the entry or exit
22 of illicit narcotics along the southwest, northern, and
23 maritime borders.

1 (2) Air and Marine operations' upgrading and
2 procurement of new platforms for rapid air and ma-
3 rine response capabilities.

4 (3) Upgrades and procurement of border sur-
5 veillance technologies along the southwest, northern,
6 and maritime borders.

7 (4) Necessary expenses, including the deploy-
8 ment of technology, relating to the biometric entry
9 and exit system under section 7208 of the Intel-
10 ligence Reform and Terrorism Prevention Act of
11 2004 (8 U.S.C. 1365b).

12 (5) Screening foreign nationals.

13 (6) Determining whether an unaccompanied
14 alien child (as defined in section 462(g) of the
15 Homeland Security Act of 2002 (6 U.S.C. 279(g)))
16 poses a danger to himself or herself or others or has
17 been charged with having committed a criminal of-
18 fense.

19 (7) Enhancing border security by combating
20 drug trafficking, including fentanyl and its precursor
21 chemicals, at the southwest, northern, and maritime
22 borders.

23 (8) Commemorating efforts and events related
24 to border security.

1 (b) RESTRICTIONS.—None of the funds made avail-
2 able under subsection (a) may be used for the procurement
3 or deployment of surveillance towers along the southwest
4 border and northern border that have not been tested and
5 accepted by U.S. Customs and Border Protection to de-
6 liver autonomous capabilities.

7 (c) DEFINITION OF AUTONOMOUS.—In this section,
8 with respect to capabilities, the term “autonomous” means
9 a system designed to apply artificial intelligence, machine
10 learning, computer vision, or other algorithms to accu-
11 rately detect, identify, classify, and track items of interest
12 in real time such that the system can make operational
13 adjustments without the active engagement of personnel
14 or continuous human command or control.

15 **SEC. ____ 05. STATE AND LOCAL ASSISTANCE.**

16 (a) STATE HOMELAND SECURITY GRANT PRO-
17 GRAMS.—In addition to amounts otherwise available, there
18 is appropriated to the Administrator of the Federal Emer-
19 gency Management Agency for fiscal year 2025, out of any
20 money in the Treasury not otherwise appropriated, to re-
21 main available until September 30, 2029, to be adminis-
22 tered under the State Homeland Security Grant Program
23 authorized under section 2004 of the Homeland Security
24 Act of 2002 (6 U.S.C. 605), to enhance State, local, and

1 Tribal security through grants, contracts, cooperative
2 agreements, and other activities—

3 (1) \$500,000,000 for State and local capabili-
4 ties to detect, identify, track, or monitor threats
5 from unmanned aircraft systems (as such term is
6 defined in section 44801 of title 49, United States
7 Code), consistent with titles 18 and 49 of the United
8 States Code;

9 (2) \$625,000,000 for security and other costs
10 related to the 2026 FIFA World Cup;

11 (3) \$1,000,000,000 for security, planning, and
12 other costs related to the 2028 Olympics; and

13 (4) \$450,000,000 for the Operation
14 Stonegarden Grant Program.

15 (b) STATE BORDER SECURITY REINFORCEMENT
16 FUND.—

17 (1) ESTABLISHMENT.—There is established, in
18 the Department of Homeland Security, a fund to be
19 known as the “State Border Security Reinforcement
20 Fund.”

21 (2) PURPOSES.—The Secretary of Homeland
22 Security shall use amounts appropriated or other-
23 wise made available for the Fund for grants to eligi-
24 ble States and units of local government for any of
25 the following purposes:

1 (A) Construction or installation of a border
2 wall, border fencing or other barrier, or buoys
3 along the southern border of the United States,
4 which may include planning, procurement of
5 materials, and personnel costs related to such
6 construction or installation.

7 (B) Any work necessary to prepare the
8 ground at or near land borders to allow con-
9 struction and maintenance of a border wall or
10 other barrier fencing.

11 (C) Detection and interdiction of persons
12 or contraband unlawfully crossing the United
13 States border.

14 (D) Relocation of aliens who are unlawfully
15 present in the United States from small popu-
16 lation centers to other domestic locations.

17 (3) APPROPRIATION.—In addition to amounts
18 otherwise available for the purposes described in
19 paragraph (2), there is appropriated for fiscal year
20 2025, out of any money in the Treasury not other-
21 wise appropriated, to the Department of Homeland
22 Security for the State Border Security Reinforce-
23 ment Fund established by paragraph (1),
24 \$10,000,000,000, to remain available until Sep-

1 tember 30, 2034, for qualified expenses for such
2 purposes.

3 (4) ELIGIBILITY.—The Secretary of Homeland
4 Security may provide grants from the fund estab-
5 lished by paragraph (1) to State agencies and units
6 of local governments for expenditures made for com-
7 pleted, ongoing, or new activities determined to be
8 eligible for such grant funding that occurred on or
9 after January 20, 2021.

10 (5) APPLICATION.—Each State desiring to
11 apply for a grant under this subsection shall submit
12 an application to the Secretary containing such in-
13 formation in support of the application as the Sec-
14 retary may require. The Secretary shall require that
15 each State include in its application the purposes for
16 which the State seeks the funds and a description of
17 how the State plans to allocate the funds. The Sec-
18 retary shall begin to accept applications not later
19 than 90 days after the date of the enactment of this
20 Act.

21 **SEC. ____ 06. PRESIDENTIAL RESIDENCE PROTECTION.**

22 (a) IN GENERAL.—In addition to amounts otherwise
23 available, there is appropriated to the Administrator of the
24 Federal Emergency Management Agency for fiscal year
25 2025, out of any money in the Treasury not otherwise ap-

1 appropriated, \$300,000,000, to remain available until Sep-
2 tember 30, 2029, for the reimbursement of extraordinary
3 law enforcement personnel costs for protection activities
4 directly and demonstrably associated with any residence
5 of the President designated pursuant to section 3 or 4 of
6 the Presidential Protection Assistance Act of 1976 (Public
7 Law 94–524; 18 U.S.C. 3056 note) to be secured by the
8 United States Secret Service.

9 (b) AVAILABILITY.—Funds appropriated under this
10 section shall be available only for costs that a State or
11 local agency—

12 (1) incurred or incurs on or after July 1, 2024;

13 (2) demonstrates to the Administrator of the
14 Federal Emergency Management Agency as being—

15 (A) in excess of typical law enforcement
16 operation costs;

17 (B) directly attributable to the provision of
18 protection described in this section; and

19 (C) associated with a nongovernmental
20 property designated pursuant to section 3 or 4
21 of the Presidential Protection Assistance Act of
22 1976 (Public Law 94–524; 18 U.S.C. 3056
23 note) to be secured by the United States Secret
24 Service; and

1 (3) certifies to the Administrator as compen-
2 sating protection activities requested by the United
3 States Secret Service.

4 **SEC. ____07. DEPARTMENT OF HOMELAND SECURITY AP-**
5 **PROPRIATIONS FOR BORDER SUPPORT.**

6 In addition to amounts otherwise available, there are
7 appropriated to the Secretary of Homeland Security for
8 fiscal year 2025, out of any money in the Treasury not
9 otherwise appropriated, \$6,000,000,000, to remain avail-
10 able until September 30, 2029, for reimbursement of costs
11 incurred in undertaking activities in support of the De-
12 partment of Homeland Security's mission to safeguard the
13 borders of the United States to protect against the illegal
14 entry of persons or contraband.
